(e) The Coal Mines (Special Provisions) Second Ordinance, 2014

- 1. The Hon'ble Supreme Court, vide its judgment/order dated 25.08.2014 and 24.09.2014, in Writ Petition (Criminal) No. 120 of 2012 and other connected matters, has cancelled the allocation of 204 coal blocks out of 218 coal blocks allocated since 1993.
- 2. In light of the judgment and order of the Hon'ble Supreme Court, it was considered expedient in public interest by the Central Government to take immediate action so as to ensure energy security of the country and to minimize and impact on core sectors such as steel, cement and power utilities, which are vital for development of the nation. As Parliament was not in session and immediate action was required to be taken by the Central Government to implement the said order and to address the above objectives, the Ordinance namely, the Coal Mines Special Provisions) Ordinance, 2014 was promulgated on 21.10.2014 under article 123 of the Constitution of India
- 3. In order to replace the Ordinance, the Coal Mines (Special Provisions) Bill, 2014 with certain modifications, was introduced in the winter session of the Lok Sabha, which was considered and passed by the Lok Sabha on 12.12.2014. The said Bill was transmitted to Rajya Sabha for condideration and passing on 18.12.2014, however it could not be taken up for consideration and passing in the Rajya Sabha.
- 4. In pursuance of the said Ordinance action has been initiated by the Central Government including the framing the rules for allocation of coal mines and it was considered necessary to give continuity to the provision of the said Ordinance and save the actions taken there under. Since, the Parliament was not in session and the said Ordinance would cease to operate w.e.f. 05.01.2015, the Coal Mines (Special Provisions) Second Ordinance, 2014 was promulgated on 26.12.2014.
- 5. On reassembly of Parliament, steps will be taken for withdrawal of the Coal Mines (Special Provisions) Bill, 2014 pending in Rajya Sabha and introduction of a fresh Bill to replace the Second Ordinance.
