## **CIRCULAR**

Subject: Engagement of Consultant in the Ministry of Coal.

In continuation of this Ministry's Circular of even no. dated 30<sup>th</sup> August 2018. The date of submission of an application for the post of Consultant in the Ministry of Coal is hereby **extended up to 25<sup>th</sup> September 2018**, so that a panel of Consultants amongst retired PA/PS/PPS from the Government of India can be prepared in this Ministry for their selection.

- 2. Candidates applying for empanelment should have a good track record of working in Ministries/Departments and should be of good health. The maximum age limit for the post of Consultants is 65 years. They will be paid a consolidated monthly fee at the following rates
  - a. Persons who got pay in Level 10 and more in revised pay scale (Grade pay Rs.5400/- or more at pre-revised pay scale) at the time of retirement will be paid Rs. 30,000/- per month.
  - b. Persons who got pay below Level 10 in revised pay scale (Grade pay less than Rs.5400/- at pre-revised pay scale) at the time of retirement will be paid Rs. 25,000/- per month.
- 3. Consultants will be engaged initially for a period of three to six months which may be extended depending on the requirement.
- 4. Persons who fulfil the eligibility criteria and who are willing to join immediately may submit their applications in the enclosed format to the Section Officer (Estt), Ministry of Coal, Room No. 104-C Wing, Shastri Bhawan, New Delhi on or before 25<sup>th</sup> September 2018.
