Monthly Summary for the Cabinet for the month of February, 2019 in respect of Ministry of Coal

A. Principal Activities

The core objectives of the Ministry of Coal are to augment coal production by adopting state-of-the-art cleancoal technologies; enhancing exploration efforts with thrust on increasing proven coal resources and developing necessary infrastructure for prompt evacuation of coal for securing its availability to meet the demand of different sectors of the economy in an eco-friendly and sustainable manner.

B. Important achievements

- 9th Monitoring Committee meeting was held on 7th February 2019 under the chairmanship of Secretary (Coal) for coal mines located in the State of Chhattisgarh.
- 10th Monitoring Committee meeting was held on 22nd February 2019 under the chairmanship of Secretary (Coal) for coal mines located in the State of Maharashtra to review the operationalization of coal mines allocated under CMSP Act, 2015.
- 11th Monitoring Committee meeting was held on 26th February 2019 under the chairmanship of Secretary (Coal) for coal mines located in the State of West Bengal to review the operationalization of coal mines allocated under CMSP Act, 2015.
- Meeting of High Power Expert Committee was conducted on 08.02.2019 regarding development of National Coal Index
- Meeting was held under chairmanship of JS (AU) on 12.02.2019 regarding Finalisation of modalities for allowing sale of coal upto 25% of the actual production in open market.
- Meeting for formulation of single Window Clearance Scheme for operationalization of coal mine on 25.02.2019.
- There are 24 operational mines. The production during the month of January, 2019 is 2.51 Million Tonne.
- Revenue in the month of February, 2019 is Rs.187.06 crore.
- Note regarding Consideration of recommendation of the High Power Expert Committee (HPEC) constituted to
 examine efficacy and challenges in the current bidding system and suggest changes for conducting auction of
 coal mines in future was approved by the Cabinet Committee on Economic Affairs (CCEA) on 19.02.2019.
- The Coal Controller Organization has reported that the total production of coal from the allocated captive coal blocks for the month of February, 2019 is 5.515 Million Tonnes (Prov.), out of which, aggregate coal production of those coal blocks which have not been cancelled by the Hon'ble Supreme Court viz. Moher & Moher Amlori Extn. (1.668 MT), Tasra (0.000 MT) and Pakri Barwadih (0.662 MT) is 2.33 Million Tonnes (prov.)

<u>Promotional Drilling:</u> A programme of Promotional/ NMET (Regional) drilling comprising 1.10 lakh meters in coal and 0.90 lakh meters in lignite has been drawn up in Annual Plan 2018-19 of CMPDI. The programme is under execution by MECL, DGMs of Nagaland & Assam and CMPDI.

As against this, the achievement of drilling upto the month of February, 2019 is 1.196 lakh metre, against the target of 1.783 lakh metre, which is 67% of the target.

Overall Progress of Detailed Drilling in 2018-19: For 2018-19, a target of 13.67 lakh metre of drilling (Departmental: 4.80 lakh metre, Outsourcing: 8.87 lakh metre) has been envisaged. As against this, 11.848 lakh metre of drilling has been carried out upto the month of February, 2019 against the target of 12.133 lakh metre, which is 98% of the target
