<u>Promotional Drilling:</u>Aprogramme comprising 6.00 lakh metres)including NER) of detailed drilling in coal has been drawn up in Annual Plan 2020-21 of CMPDI, through departmental resources and outsourcing.

As against this, the achievement of drilling during the month of April, 2020 is 0.004 lakh metre, against the target of 0.07 lakh metre, which is 6% of the target.

Overall Progress of Detailed Drilling in 2019-20: For 2020-21, a target of 13.00 lakh metre of drilling (Departmental: 4.75 lakh metre, Outsourcing: 8.25 lakh metre) has been envisaged. As against this, 0.20 lakh metre of drilling has been carried out during the month of April, 2020 against the target of 0.49 lakh metre, which is 40% of the target.
