ORDER

Subject: The Coal Mines (Special Provisions) Act, 2015 and Hon'ble High Court of Delhi, Judgment dated March 09, 2017– Valuation of Compensation for payment to prior allottee (M/s West Bengal Mineral Development and Trading Corporation Limited (WBMDTC Ltd.) Reg, for East of Jaganathpur B Coal Block/Mine.

By Order dated January 25, 2021 both prior allottees, M/s West Bengal Mineral Development and Trading Corporation Limited (WBMDTC) and present allottee, M/s Powerplus Traders Private Limited (PTP.Ltd) were called upon February 04, 2021 at 3:00 P.M to present their comments/objection, if any, on the determination made by the Nominated Authority. The said meeting was re-scheduled on same date at 2:45 P.M.

2. Accordingly, both prior allottee, M/s WBMDTC Ltd. and successful allottee, M/s PTP Ltd attended the meeting on February 04, 2021 and accepted the claim of compensation of Land and Mine Infrastructure as determined by the Nominated Authority vide order dated January 25, 2021.(i.e NIL for Jaganathpur B Coal Block/Mine).

3. **In respect of Cost of Geological Report amounting to INR 6, 38, 61,720/-** the same has been released by O/o NA vide order dated January 22, 2021 and Coal Controller is directed for further disbursement of the same under the provision of the Coal Mines (special Provisions) Act, 2015 to the prior allottee immediately of the transfer of above amount from PAO (Copy Enclosed).


4. **Geological Report (GR):** - In addition to above, Prior allottee is directed to handover the original GR to successful allottee immediately.

5. In view of above, the valuation of compensation for Land and Mine Infrastructure for Jaganathpur B Coal Block/Mine stands settled as NIL.

6. In accordance with Section 27 of the Act and the judgment dated March 09, 2017, it is open to M/s WBMDTC Ltd. and M/s PTP.Ltd to raise disputes with regard to the quantum of compensation before the Tribunal constituted under the Coal Bearing Areas (Acquisition and Development) Act, 1957.
