(a) the number of First Mile Connectivity projects under implementation by the Government and the location of these projects, State-wise;

(c) the expenditure likely to be incurred by the coal companies to improve the First Mile Connectivity in the coal mines; and

(d) whether the Government has set any time frame in this regard and if so, the details thereof?

(a) to (d): First Mile Connectivity (FMC) is being implemented in coal mines of production capacity exceeding 4 Million Tonne Per Annum (MTPA) with a view to ease the living of people residing in coal mines areas by reducing traffic congestion, road accidents, adverse effects on environment and health by enhancing coal handling efficiency through employing alternate transport methods like mechanized conveyor system and computerized loading into railway rakes, use of Conveyor Coal Transport and Mechanized Loading through SILOs. There are 39 FMC projects under implementation. The details of FMC projects i.e. Name of the Project, Location, Estimated CAPEX and expected date of Commissioning is at Annexure.
