FINAL COMPENSATION ORDER

Subject: Determination of Compensation to prior allottee, M/s Jharkhand State Mineral Development Corporation Limited, of Burakhap Small Patch coal mine.

Provisional determination of compensation of Cost of Geological Report ('GR'), Cost of Consents ('CC'), Land and Mine Infrastructure was issued on June 28, 2023 in accordance with Coal Mines (Special Provisions) Act, 2015 and Hon'ble High Court of Delhi's Judgment dated March 09, 2017. The summary of compensation determined as per the aforementioned Provisional Order is as under:-

2. Further, in the said provisional compensation order following directions were issued in respect of Burakhap Small Patch coal mine :-

- a) M/s JSMDCL is entitled to receive compensation for cost of GR amounting to INR 65,10,969/-.
- b) M/s M/s Shreesatya Mines Private Limited (SMPL) is entitled to get refund of excess fixed cost deposited with MoC i.e. INR 1,95,84,021/-.

3. Thereafter, pursuant to Provisional Order dated June 28, 2023, M/s Jharkhand State Mineral Development Corporation Limited (hereinafter 'JSMDCL') (Prior allottee) and M/s Shreesatya Mines Private Limited (hereinafter 'SMPL') (Successful allottee) were granted a chance on June 30, 2023 at 15:00 to present their comments/objections, if any, on the above-mentioned compensation determined. Accordingly, both prior and successful allottees attended the meeting on June 30, 2023 and accepted the compensation determined in provisional order dated June 28, 2023 for Geological Report, Cost of Consents, land and mine infrastructure.

4. Hence, the compensation determined by the provisional order dated June 28, 2023 stands final.

5. Additionally, M/s JSMDCL (prior allottee) is hereby directed to handover / share the original documents (like Geological Report) and CAD files (soft copies) to successful allottee in accordance with following provisions of CM (SP) Act 2015 :-

- a. Vesting Order is issued as per Section 8 (4) of the Coal Mines (Special Provisions) Act, 2015 which transfers and vests upon the Successful Bidder, all the rights, title and interest of the prior allottee, entitlement to mining lease to be granted by the State Government, any statutory license, permit, permission, approval or consent required to undertake coal mining operations in Schedule I coal mines, if already issued to the prior Allottee.
- b. Further, as per clauses (a),(b),(c) and (d) of section 23 of CM(SP) Act 2015, "if any person obstructs or causes any impediment in taking possession or fails to deliver to the designated custodian any books of account, registers or any other document in his custody relating or destroys or misuses any mine infrastructure or coal stock or retains any property of such coal mine or removes or destroys it, he and any officer-in-default of the company shall be punishable with imprisonment for a term which may extend to two years, or with minimum fine of one lakh rupees per day and in case of continuing failure, with a maximum fine of two lakh rupees

for every day during which failure continues or with both, depending upon the nature of the offence."

6. In accordance with section 27 of the Act and the judgement dated 09.03.2017, it is open to M/s Jharkhand State Mineral Development Corporation and M/s Shreesatya Mines Private Limited to raise disputes with regard to the quantum of compensation before the Tribunal constituted under the Coal Bearing area (Acquisition and Development) Act 1957.
