Sir/Madam,

I am directed to convey the sanction of the President to the transfer of a sum of **INR 7,19,14,540/-** (In words:-Seven Crore Nineteen Lakh Fourteen Thousand Five Hundred Forty Only) to the prior allottees, M/s C.T Mining Pvt Ltd (JV of M/s Rungta Mines Limited and M/s Sunflag Iron & Steel Co. Ltd)' under the provisions of the Coal Mines (Special Provisions) Act, 2015 by the Coal Controller in his capacity as 'Commissioner of Payments' towards compensation of following costs incurred by prior allottee that is mentioned as under :-

Here, it is pertinent to mention that in accordance with the Coal Mines (Special Provisions) Act, 2015 ("Act") and the Coal Mines (Special Provision) Rules, 2014 ("Rules"), the Nominated Authority had issued Notice dated 19.06.2023 inviting claims from Secured Creditors/Government Authorities in respect of Schedule I coal mine.

In pursuance of the aforesaid notices, no claims have been received from secured creditors, Government of India, any of the department or ministries of the Government of India, State Government(s), any of the department or ministries of the State Government(s) and Local Authority (ies) against the prior allottees for certain coal mines.
