Minutes of the 20th meeting of Scrutiny Committee held on 27.07.2023 and 28.07.2023 to consider/examine the submissions/replies of Allottees against the Show Cause Notices for deviation from milestones mentioned in Coal Mines Development and Production Agreement.

The Chairman of the Scrutiny Committee welcomed all the members of the committee and the participants. Minewise discussions on Show Cause Notices and corresponding replies were held and Allottees were given the opportunity to share their point of view.

#### 1. Gare Palma Sector II - M/s Maharashtra State Power Generation Co. Ltd

Show Cause Notices dated 24.12.2020, 19.01.2022 & 26.05.2023 for non – compliance with the land acquisition, opening of Escrow Account, Mine opening permission, and Coal production in FY 2022-23 milestones and corresponding replies of the Allottee were considered by the Scrutiny Committee.

Show Cause Due Dates - (i) Land Acquisition:17.11.2020 (ii) Opening of Escrow Account: 17.11.2020 (iii) Application for Opening Permission: 17.12.2020 Due Date (i) Grant of Mine Opening Permission: 17.01.2021 Schedule Production for FY 2022-23: 0.25 MT	In the beginning, O/o Nominated Authority informed that the issues were earlier considered in the 14 <sup>th</sup> & 17th meetings of the Scrutiny Committee held on 09/10.03.2021 & 02.03.2022 respectively. In the 17th meeting of the Scrutiny Committee, the committee advised the Allottee to submit the chronological details of the efforts made by them for the purpose of obtaining EC/FC, CA land and other categories of land to the O/o NA. The committee advised the O/o NA to send these chronological details along with Show Cause notices to State Government and seek their comments. Accordingly, M/s MAHAGENCO vide letter dated 13.05.2022 submitted the chronological details of the efforts made by them to O/o NA which was further forwarded to GoCG vide letter dated 04.07.2023 to GoCG requesting their comments on the matter. However, the reply from Chhattisgarh State Government is still awaited.

informed that FC stage-II was granted on 27.01.2023. However, even after several requests from M/s MAHAGENCO and DO letter from MoC, State government has neither issued the FC Stage-II order nor handed over forest land to them. Due to
this, the execution of mining lease and other successive activities are still pending. The Committee inquired from the state government about the delay in transfer of forest land. State officials informed them that the necessary communication has been sent to the forest department and decision is pending thereby.
Regarding delay in land acquisition, the Allottee further stated that illegal construction has taken place within the mining lease area and that the asset survey could not be carried out due to resistance from the local villagers.

#### **Observations and Recommendations of the Committee:**

It was observed that the completion of land acquisition and other successive milestones have been delayed due to delay in grant of EC and FC. The application of EC and FC were stuck at the State Government level. It is seen that even after grant of FC stage-II by MoEF&CC, the forest land has not been transferred to the Allottee. Thus, the Committee is of the view that the Allottee cannot be held responsible for the delay in achieving the said milestones, as the timely achievement was beyond the control of the Allottee. Since Land Acquisition was delayed, there was delay in applying for Mine Opening Permission and Escrow account opening.

In view of these points, the committee recommended for not imposing any penalty on the Allottee for delay in completion of the milestones mentioned in the show cause notices as they are not found to be responsible for the delay.

## 2. Gare Palma IV/8 – M/s Ambuja Cements Limited

Show Cause Notices dated 09.09.2020 &17.06.2021 for deviation in the scheduled production/Reaching Rated Capacity for the year 2019-20 and 2020-21 and the corresponding replies of the Allottee were considered by the Scrutiny Committee.

	The representative of CMPDIL stated that the FY 2018-19 has been considered as the
	first year, in which production from the opencast mine has been envisaged as 0.10 MT
	and zero from underground mine. For FY 2019-20, the production from the underground
	mine should have been 0.20 MT and 0.4 MT from the opencast mine.

	Allottee informed that there was a delay of 24 months in land acquisition as the land issue
	was sub-judice in Bilaspur high court. They didn't get land for underground mining in
	time. They got the possession of forest land in December 2018 and Mine Opening
	permission was obtained in January 2019. Allottee further stated that they applied for
	CTO for operation in underground mine on 30.10.2019, however, they obtained it on
	29.12.2020 after the intervention of the O/o Nominated authority.
	The Allottee further informed that they have achieved PRC of 1.2 MTPA in FY 2022-23
	and certainly will achieve the PRC in the current year.

#### **Observations and Recommendations of the Committee:**

For Shortfall in Production in FY 2019-20: The committee observed that the production target of 0.4 MT from opencast mine was achieved by the Allottee. However, the production target of 0.2 MT from Underground Mine could not be achieved due to a delay in grant of CTO from the State pollution control board and it was granted only after the intervention of O/o Nominated Authority. Hence, the Committee recommended for not imposing any penalty as the shortage in production is not attributable to the Allottee and also, they have achieved PRC of 1.2 MT in FY 2022-23 as scheduled.

**For Shortfall in Production in FY 2020-21:** The committee observed that the Transit Pass was withheld from August 2020 to March 2021 by the State government and the production from the mine was done only in the first 4 months of the financial year 2020-21. In the first four months, they had produced about 0.17 MT coal.

Therefore, the Committee was of the view that the shortage in coal production cannot be attributed to the Allottee and hence recommended for not imposing any penalty on the company.

# 3. Parsa East and KantaBasan-M/s Rajasthan Rajya Vidyut Utpadan Nigam Limited

Show Cause Notices dated 09.07.2019 and 04.10.2021 for deviation in the scheduled production/Reaching Rated Capacity for the year FY 2017-18 and Transfer/Grant of Mining Lease and corresponding replies of Allottee were considered by the Scrutiny Committee.

The allottee had stated that they had Environment Clearance (EC) of 10 MT and had applied for EC for 15 MT and there was delay in grant of EC for 15 MT. The Committee observed the Allottee had EC for 10 MT, but production was only 8.33 MT in FY 2017-18 which was less than the approved EC capacity. The Committee also observed during the 10<sup>th</sup> meeting on 05.06.2020 that the matter had gone to the Court in the matter of the appropriation of the Performance Security for shortfall in coal production in FY 2015-16 and FY 2016-17. Therefore, the Committee will be able to decide the matter based on the outcome of the court case. The matter may be put before the Scrutiny Committee after court decision.</li> <li>O/o Nominated authority informed that Hon'ble Bilaspur Tribunal vide its order dated 29.03.2023 has dismissed the petition of M/s RRVUNL in relation to the appropriation of the Performance Security for shortfall in coal production in FY 2015-16 and FY 2016-17 and the Allottee has appealed before the hon'ble high court of Chhattisgarh.</li> <li>During deliberation M/s RRVUNL once again reiterated that they could not achieve the Scheduled Production target of 15 MT as they had EC of only 10 MT in 2017-18. Then the Committee inquired that in that case why even 10 MT coal was not produced. The Allottee then informed that the shortage was due to the dispatch constraints. There was lack of railway infrastructure and evacuation of such a big quantity of coal through road was very difficult. The mine is in a Greenfield location of Hasdeo Arand Area, devoid of railway infrastructure required for coal evacuation, and the nearest railway siding was about 85 km away from the mine site. The railway siding from Sarguja road to PEKB mine boundary was completed only in April 2018 resulting in less coal production in FY 2017-18.</li> </ul>

	Allottee further informed that the district administration had allowed transportation of coal though road only for a limited hour per day.
	<b>Regarding delay in transfer of Mining lease</b> , Allottee informed that they had submitted the application for revalidation of the Mining Lease on 30.04.2015. The revalidated EC & FC was issued by MoEF&CC on 19.06.2015 and 26.06.2015 respectively which was further submitted to the State Mines Department on 26.06.2015. Mineral Resource Department of Chhattisgarh revalidated the Mining lease on 02.11.2015 and thus, the delay was on part of the state government.

#### Observations and Recommendations of the Committee:

**Regarding Shortfall of Coal Production in FY 2017-18:** The committee observed that M/s RRVUNL being the prior Allottee of the mine was well aware of the evacuation infrastructure constraints issues at the mine site and should have systematically planned to tackle it from the time of allocation in the year 2015 itself. The Allottee was not able to produce even 10MT coal for which EC was available. The committee is therefore of the opinion that the responsibility for shortage in coal production in FY 2017-18 is attributable to the Allottee. Therefore, the committee recommended for appropriation of PBG for shortfall in coal production in FY 2017-18 as per the provision of the Allottment Agreement.

**Regarding Transfer/Grant of Mining Lease:** Show cause notice was issued on 04.10.21 for delay in grant/transfer of mining lease. The Committee is of the opinion that the major reason for the delay is procedural delay in the office of DC, Sarguja and for this delay allottee cannot be made responsible. The Committee, therefore, recommended for not imposing any penalty for delay in grant of mining lease.

#### 4. Talaipalli Coal Mine- M/s NTPC Ltd.

Show Cause Notices dated 06.09.2022 and 19.05.2023 for deviation in the Scheduled production/Reaching Rated Capacity for the year 2021-22 and 2022-23 respectively and the corresponding replies of the Allottee were considered in the meeting.

TEMPL also filed a commercial civil suit before the Hon'ble Delhi High Court on 05.05.2021 requesting the refund of Bank Guarantee and expenditure incurred during mobilization. As per the direction of Hon'ble Delhi High Court dated 10.05.2021, discussions took place between M/s NTPC and M/s TEMPL for amicable settlement. However, settlement could not be reached and subsequently the MDO contract was terminated on 18.01.2022.
	O/o Nominated Authority informed that that in its earlier meeting, the Scrutiny Committee had recommended for appropriation of PBG for shortfall in coal production for FY 2019-20 and FY 2020-21. Accordingly, a sanction order was issued for appropriation of PBG. NTPC filed a writ petition before the Hon'ble High Court of Delhi challenging the appropriation order dated 06.07.2022 for the appropriation of PBG against non-achievement of coal production targets for FY 2019-20 & 2020-21. The matter is sub-judice and the Committee may decide on the shortfall in production in FY 2021-22 and FY 2022-23 independently.

## **Observations and Recommendations of the Committee:**

The representatives of M/s NTPC explained the reasons for non-performance which essentially has arisen due to the failure of MDO to deliver as per the contract. The Committee is of the view that despite efforts by M/s NTPC, the MDO issue could not be resolved in time and it contributed to the delay in starting coal production. The Committee was constrained to take a view that the matter of selection of MDO falls exclusively within the ambit of Allottee. Any failure on account of non-performance by the MDO cannot justify waiver of imposition of penalty as per the Coal Mine Development and Production Agreement (CMDPA). Therefore, the Committee recommended for appropriation of PBG for shortfall in coal production in FY 2021-22 and FY 2022-23 as per the provision of the CMDPA.

#### 5. ChattiBariatu and ChattiBariatu South - M/s NTPC Limited

Show Cause Notice dated 17.05.2023 for deviation in the Scheduled production/Reaching Rated Capacity for the year 2022-23 and corresponding reply of the Allottee was considered in the meeting.

Target; 7.0 MTPA Actual: 0.576 MTPA	The Allottee informed that they have achieved 17 parameters within the scheduled timeline out of total 18 parameters. They appointed M/s BGR Mining & Infra Ltd as MDO on 13.11.2017. However, due to some issues involving a CBI case, the MDO contract became sub-judice and finally the contract was terminated on 04.07.2019. Fresh NIT for MDO appointment was issued on 19.08.2019. However, contract could not be awarded due to very high price quoted by the L1 bidder. Fresh NIT was issued on 25.11.2020 and MDO contract was awarded to M/s AMR-Rithwik Consortium on 02.10.2021. The Allottee further informed that that Law & Order in the area is a major challenge, and 3 employees were shot dead by the miscreants. The mine got mine opening permission within the scheduled timeline, however, coal production could be started only in September 2022 due to MDO issue. Due to resistance of local villagers along the dispatch road, coal evacuation from the mine is always a challenge. O/o Nominated Authority informed that that in its earlier meeting, the Scrutiny Committee had recommended for appropriation of PBG for shortfall in coal production for FY 2019-20, FY 2020-21 and FY 2021-22 and accordingly, PBG has been appropriated. In the end, the representative of NTPC also stated that penalty for every year slippage from coal production target of the order of 8% of total PBG is rather too high; particularly as the reason for such penalty is same. They appealed that they have represented the matter to be honorable high court and therefore the decision on the said issue may be deferred till the order of the honorable court.

#### **Observation & Recommendation:**

The Committee observed that the Show Cause Notice was issued to NTPC for production of only 0.576 MT coal against the target of 7.0 MT in FY 2022-23. The cause for failure in achieving the target production was attributed to the non-performance of MDO operator and certain court cases resulting from such appointment. The Committee is of the view that the responsibility of selection and appointment of MDO and production of coal up to the target quantity is entirely that Allottee. Hence, failure in doing so cannot be considered as grounds for waiver of penalty through non invocation of BG. Any failure on account of non-performance by the MDO cannot justify waiver of imposition of penalty as per the Coal Mine Development and Production Agreement (CMDPA).

Therefore, the Committee recommended for appropriation of PBG for shortfall in coal production in FY 2022-23 as per the provision of the CMDPA.

# 6. Tubed Coal Mine: - M/s DVC

Show Cause Notices dated 22.03.2017, 19.03.2018, 13.09.2018, 01.02.2022, 26.05.2022 & 18.05.2023 for delay in grant of Environment Clearance, Forest Clearance, Land acquisition, opening of Escrow account, mine opening permission and for deviation in the scheduled production/Reaching Rated Capacity for the year 2020-21, 2021-22 & 2022-23 and the corresponding replies of the Allottee were considered in the meeting.

#### **Observation & Recommendation: -**

1. The Allottee was given six show cause notices on slippage of various milestones. On detailed examination of the replies, it was found that though there was delay in submission of application for ML, the ML was granted within the given timeline. The Committee also observed that there was delay of only 18 days in submission of FC application. The Committee is of the view that since delay in submitting application for ML has not resulted in delay in grant of ML, and there was minor delay in submission of FC application, therefore, the committee recommended for not imposing penalty for delay in submission of ML application and for delay in submission of application for FO application for FO application.

2. For delay in grant of other clearances, the committee took note of the recommendation of 13th Scrutiny Committee meeting held on 26.11.2020 where the delay has been attributed to both State Government and Allottee. Accordingly, on the recommendation of 13th and 18th SCM the O/o NA sought the comment of State Government on the submission made by the Allottee. Despite periodic follow up, no response has been received so far from Government of Jharkhand (GoJ).

The Committee is of the view that the decision on these show cause notices cannot be further deferred as these have been deferred so many times in the past.

Accordingly, the Committee, on the basis of the reply of the Allottee and in line with the recommendation of the 13<sup>th</sup> Scrutiny Committee, comes to the conclusion that except for delay in application for ML and application for FC, the Allottee is responsible for failure in timely completion of the milestones given in the show cause notices and therefore, Committee recommended for appropriation of PBG as per the Allottment Agreement.

#### **Observation & Recommendation:**

However, the state government has not given any response. Further, it is noted that EC and FC-I has been obtained and Forest Clearance (FC –II) is pending. The Committee, therefore, took a view that the issues should be placed before the Committee after grant of FC-II and after the response from State government is received. However, in case of absence of response from State government, the O/o NA should analyze the submissions made by the Allottee as M/s CCL is a PSU under MoC. Based on the submission of Allottee, comment of state government and office of NA, the Committee will give its recommendation in the next meeting.

#### 8. Jogeshwar& Khas Jogeshwar: - M/s Southwest Pinnacle Exploration Limited (SWPE)

Show Cause Notice dated 28.03.2023 for delay in grant of Prospective License, Drilling/Exploration and preparation of Geological Report and corresponding reply of the Allottee was considered in the meeting.

submission of complete application with all necessary documents to the concerned
authority is the responsibility of the Allottee.

#### **Observation & Recommendation: -**

The Allottee was given the show cause notice for the delay in MS-I which includes Prospecting License or notification under section 4 of the CBA Act, 1957, as applicable, completion of drilling/exploration and preparation of geological report (GR). The due date for completion of MS-1 is 17.02.2023. and it is still pending. The Allottee presented in chronological order the various factors for the delay. The Committee, on perusal of these submissions, came to the conclusion that the Allottee had not submitted the complete application and it is their responsibility for submission of application which is complete in all aspects. The state authority is right in seeking additional documents which are required for processing the application. In view of this, the Committee found the Allottee responsible for the delay in completion of MS-1 and therefore recommended for appropriation of PBG as per the CMDPA.

#### 9. Brahmadiha Coal Mine: - M/s Andhra Pradesh Mineral Development Corporation (APMDC)

Show Cause Notice dated 16.06.2023 for delay in grant of Environment Clearance and the corresponding reply of the Allottee was considered in the meeting.

For delay in grant of Environment Clearance, - Due date is 01.06.2023 and actual date is 19.06.2023.	The Allottee informed that they had applied for the transfer of EC on Parivesh portal within given timeline. They stated that MoEF&CC took 11 months 10 days to take a policy view in transfer of EC for the project area less than 150 ha. Finally, after a gap of about 11 months, MoEF&CC advised APMDC to apply for a fresh EC to State Environment Impact Assessment Authority (SEIAA). APMDC immediately applied to SEIAA and they have taken expeditious actions in all aspects of EC processes and EC was approved by appropriate authority well within given timeline on 28.05.2023 and EC letter was issued on 19.06.2023.

#### **Observation & Recommendation: -**

The allottee was given Show cause notice on 16.06.23 for delay in grant of Environment Clearance (EC). The scheduled date of EC was 01.06.23 and against this, EC was granted on 19.06.23. In view of the details given by the Allottee, it is found that even after substantial delay by MoEF&CC in giving advice to the Allottee to apply afresh to SEIAA, the EC was approved by the competent authority within the given timeline and only there was

slight delay in issuing grant letter. Therefore, for the delay in grant of EC, the Allottee is not responsible, and the Committee recommended for not imposing any penalty for this milestone.

#### 10. Suliyari Coal Mine - M/s Andhra Pradesh Mineral Development Corporation (APMDC)

Show cause notice dated 03.07.2023 for deviation in the scheduled production/Reaching Rated Capacity for the year 2022-23 and the corresponding reply of the Allottee was deliberated in the meeting.

Schedule production for FY 2022-23	<ul> <li>Allottee informed that the shortage in coal production for FY 2022-23 is due to geological disturbances and the law &amp; order problem. They found that there was a 40 to 60 meter down throw fault which was not shown in the mining plan. Due to this, the stripping ratio increased from 5.11 to 10.27. As per the mining plan, the designated OB removal was 12.78 million cubic meter to get 2.5 MT of coal but the actual OB removal due to the occurrence of fault was 20.32 million cubic meter and the actual coal production was 1.95 MT. This affected the targeted coal production for the 1<sup>st</sup> and 2<sup>nd</sup> year of scheduled production.</li> <li>Allottee also stated that the preliminary valuation of the land was done prior to year 2014 and when the award was passed, the villagers were not agreeing with</li> </ul>
	this. The villagers also built additional structures on the site and resisted mining operation. All this led to law-and-order problem.
	Allottee stated that at the time of award, 3 areas of land stretching to 33.39 Ha did not form part of the award as district administration could not decide whether it was govt. land or tenancy land. However, the District Collector had declared 15.43 ha as tenancy land and 17.59 ha as Govt. land. Aggrieved by a decision of the district administration, the occupants of land that was declared as government land went to the High Court, Jabalpur. High Court, Jabalpur passed a stay order which continued till the final disposal of the matter on 15.03.2023. This area was falling in the middle of mine during the first year of operations. Due to the non-availability of this critical land area, APMDC was restricted to doing smaller blasting, and thus the desired progress was drastically reduced. This has been a major cause leading to the restricted continuity of the Mining operations and severely impeded planned production of coal.

#### **Observation & Recommendation: -**

The Allottee was served the show cause notice for shortfall in production in FY 2022-23 as against the target production of 2.5 MT, the production was 1.95MT only. In respect of this, the representative of APMDCL submitted that they faced a down throw fault of 40 to 60 m which was not shown in the mining plan which led to

the increased stripping ratio from 5.11 to 10.27. They also faced resistance of villagers and non -availability of a patch of critical land area.

In view of the geological disturbances and other challenges faced by the Allottee and their promise that they will achieve PRC in the current year, the Committee recommended for not imposing any penalty for shortfall in production in FY 2022-23.

#### 11. Bikram Coal mine: - M/s Birla Corporation Limited

Show cause notice dated 05.09.2022 for the delay in grant of FC Stage-II, Wildlife Clearance and approval under PESA and the corresponding reply of the Allottee were considered in the meeting.

For delay in Grant of FC Stage-II, Wildlife Clearance and approval under PESA	O/o Nominated Authority informed that the issue was earlier considered in the 19th meeting of the Scrutiny Committee held on 19/20.04.2023. The Allottee had assured that FC-II will be granted by June 23 and the Committee deferred the decision and recommended to reconsider it after June 23.
Due date: 10.08.2022, Actual date: Still pending.	The Allottee informed that there is discrepancy in the land record as mentioned by the revenue department and forest department across the state of Madhya Pradesh. Compensatory Afforestation land was identified in the district of Chhindwara and cleared by both departments at various levels and suitability certificate was also issued by DFO. However, Western Coalfield Limited (WCL) raised an objection that the identified CA land is falling under its Mining Lease Area. This detail was not present in any of the government or forest revenue records. The revenue department issued a letter withdrawing the availability of this land for CA purpose. In the process, they lost 4 crucial months. Still, they succeeded in getting FC stage-I clearance on 21.04.2022 against the scheduled date of 10.02.2022. The Allottee further stated that they have made all-out efforts for timely completion of FC stage I, however, due to land record issue of state government and objection of WCL, it was slightly delayed. Another proposal for a parcel of Government land identified in the District of Shahdol had to be abandoned due to similar issues. A third parcel of private land in Satna district is identified and IRO inspection by the MoEF&CC team was conducted on 15th June 2023 and the CA scheme was prepared by DFO, Shahdol. Allottee informed that during the meeting with Secretary, Coal in July 2023, PCCF (land Management) assured that the demand note against the CA scheme will be raised by the end of July 2023. They are following up with state forest department on day-to-day basis.

In addition, MDO has been appointed. CTE is in place and once FC-II is granted, they will apply for CTO. Allottee further stated they are hopeful to start coal production in current financial year itself.

#### **Observation & Recommendation: -**

During the 19<sup>th</sup> meeting of the Committee, it had observed substantial progress in the mine and the Allottee had given assurance to get Forest Clearance Stage-II by the end of June 2023. Because of this, the Committee had then decided to reconsider the issue after June 23 in next meeting. The Allottee has informed that the wildlife clearance is not required for this mine, and they will certainly get FC-II in two months' time. The allottee has also confirmed that they will start coal production ahead of the scheduled timeline in FY 2023-24 itself and for which they will give commitment in writing to the O/o NA by 15<sup>th</sup> August 2023.

In view of the above, the Committee decided to hold the decision in abeyance for two months and they will consider the matter for final decision in the Scrutiny Committee Meeting to be held thereafter.

#### 12. Sarisatolli Coal Mine - M/s CESC Limited

Show Cause Notices dated 13.10.2020, 30.06.2021, 05.09.2022 & 29.05.2023 for deviation from milestones for non-compliance with the scheduled production as per the approved Mine Plan from 2017-18 to 2022-23 and corresponding replies of the Allottee were considered by the Scrutiny Committee.

Shortfall in coal Production from the scheduled production for the year FY 2017-18, FY 2018-19, FY 2019-20, FY 2020- 21, FY 2021-22, and FY 2022-23	O/o NA informed that the issue of shortfall in coal production in FY 2017-18, FY 2018- 19 and FY 2019-20 was considered in the 17 <sup>th</sup> meeting of the Scrutiny Committee wherein it had recommended for detailed study by CMPDIL to find out the annual coal production capacity of the mine. Accordingly, CMPDIL was assigned the task of finding out the annual production capacity of the mine. CMPDIL has submitted the study report. The report provides an assessment of the balance reserve in the remaining active area of the mine, and it excludes certain areas that could not be mined due to various constraints such as the presence of graveyard, village and other social issues. The report states that the estimated reserve in the active working area is about 4.43 MT, however, factors such as fire and development haven't been accounted for determining the balance mineable reserve and actual reserve may vary based on the extent of fire and developed workings during actual operations. The report also mentions that additional reserve could be made potentially available from the high wall side and from the areas locked up due to presence of the Diguli village in the east and Rakhakura village and graveyard in the south. However, this would require land acquisition and significant re-handling of the dumped overburden. The report further stated that after taking into consideration of all the constraints, the annual production capacity of the mine is estimated to range from about 1.3 MT to 1.6 MT. The Committee observed that it is not clear from the CMPDIL report that from which year the production capacity of the mine has reduced from original capacity of 3.5 MT and how CMPDIL can assess that the land can't be acquired. The Allottee informed that a district road is passing through the mine, and it has created obstacles in the mining operation. Also, high tension electric lines and water pipelina ere passing along the road. They have applied for shifting of this road; however, state government has still not given permission for this.

#### **Observation & Recommendation: -**

The Committee is of the opinion that the some of the constraints such as presence of some villages, road, graveyard etc. are generally found in several other coal mining blocks also. The Committee, therefore, advised Allottee to submit a chronological detail of the efforts made by them for removal of such constraints along with the supporting documents to the O/o NA. The office of NA was advised to send the reply of the Allottee having the details of the effort made by them to the government of West Bengal and seek its perspective on the issues within a timeline of 2 months. Regarding Jhama, MoC should make a policy for its disposal.

The Committee also observed that CMPDIL in its report has reduced the annual production capacity to the range of 1.3 MT to 1.6 MT from 3.5 MT, however, it has not specified the period from which the production capacity has reduced .It is not clear from the report that what may be taken as the annual production capacity for the period for which the show cause notices have been issued. Therefore, the Committee advised O/o NA to advise CMPDIL to find out the period from which the production capacity has reduced in range of 1.3MT to 1.6 MT and what may be considered as the achievable annual capacity for the period from FY 2017-18 to FY 2022-23.

The Committee recommended that based on the inputs from CMPDIL, GoWB and MoC, the issue of shortfall in production from FY 2017-18 to FY 2022-23 will be discussed in details in next meeting and till that time the decision is deferred.

# 13. Kasta East Coal Mine – M/s Jitusol Developers Private Limited (JDPL)

Show Cause Notice dated 27.06.2023 was issued for failure in approval of Mining Plan within the scheduled date as per the CMDPA. The show cause notice and the corresponding reply of the Allottee were considered by the Scrutiny Committee.

May, 2023 for approval. The first observation was received on 5th July 2023 which was replied within 7 days. The 2nd observation was received on 6th July 2023.
JDPL asserted that there was no delay in preparation and submission of Mining Plan after the certification of boundary by CMPDIL. Therefore, the delay in the Mining Plan approval should not be attributed to them, as the work could only commence after the clarification of the coal block boundaries by CMPDIL on March 3, 2023.
The representative of CMPDIL and Director (Tech)/NA stated that the presence of the mine in more than one state does not affect the preparation of the Mining Plan.

#### **Observation & Recommendation: -**

The show cause notice was issued to the Allottee due to the delay in approval of the Mining Plan whose due date was 12.06. 2023. The Allottee gave an explanation and stated that contrary to the vesting order, the block falls within two states instead of just one state. Only a small portion of the block falls within the boundary of Jharkhand state and remaining area is in West Bengal.

Consequently, the process included preparation of DGPS survey report and certification of block boundary from CMPDIL. It was observed that the DGPS survey was completed in Feb 23 and block boundary certification was obtained on 3<sup>rd</sup> March 23. Subsequently, the Mining Plan proposal was uploaded on the SWCS portal on 18.05.2023.

The Committee observed that the block boundary falls in two states and therefore extra time may be required for completion of DGPS survey and thus for obtaining Mining Plan approval. In consultation with the representative of CMPDIL, the Committee has come to the conclusion that two-month extra timeframe from today is appropriate for the approval of the Mining Plan. During this period, the decision on delay in grant of Mining plan will be kept in abeyance. The final decision will be made based on whether the Mine Plan is approved within the specified two-month period or not.

## 14. Utkal D & Utkal E Coal Mine – M/s NALCO Limited

Show Cause Notices dated 08.11.2021, 10.03.2022, 30.06.2022 & 31.08.2022 for delay in completion of the various Efficiency Parameters and the corresponding replies of Allottee were considered by the Scrutiny Committee. After a detailed discussion with the Allottee, it was revealed that these clearances are available separately for Utkal D & Utkal E blocks, but not for the combined Utkal D&E block. The Allottee was advised by the Committee to obtain the necessary statutory clearances for the combined Utkal D&E block by March 2024. Until then, the Committee recommended to keep the decision on the show cause notices in abeyance.

# 15. Manoharpur & Dipside Manoharpur Coal Mine: - M/s M/s Odisha Coal and Power Limited (OCPL)

	<b>Coal Production in FY 2020-21</b> : Considering prevailing Covid-19 situation in the State, Gov. of Odisha on 13.01.2021 had requested Ministry of Coal for relaxation of target to 2.0 MT. However, MoC relaxed to 3.0 MT only. As stated above, MoEF&CC issued OM on 14-05-2020 allowing change in calendar plan of EC in peak COVID-19 period. In H1 of FY20-21, the mine is able to produce only 0.28MT and after easing of COVID-19 restrictions the mine produced 1.72MT in H2 of FY2020-21. Although Calendar Plan of approved Mine Plan Rev-II and III are different (2.5 and 4.0 MT respectively) the Production target in 4th year of operation FY 2022-23 is 8.0 MT.	

#### **Observation & Recommendation:**

The show cause notice was issued to the Allottee on seven counts for delay in obtaining various clearances such as Forest Clearance, Environmental Clearance, opening of escrow account, application of mine opening permission, grant of mine opening permission and shortfall in scheduled production. During the discussion, the Allottee explained that the integrated mine plan was submitted in July 2018 as per the direction of the MoC and it was approved in September 2019. Therefore, the scheduled production as mentioned in the show cause notices do not align with the calendar program of the integrated Mining Plan.

In view of this, the committee advised O/o NA to look into the matter and specify the scheduled dates for completion of each and every milestone. Based on the decision of O/o NA for the new scheduled dates for various clearances and scheduled production for different years, the committee will decide on the show cause notice served to the Allottee in the next meeting.

#### 16. Nerad Malegaon Coal Mine: - M/s Indrajit Power Private Limited

Show Cause Notices dated 03.09.2021, 01.06.2022, and 05.06.2023 for deviation from Schedule Production/Reaching Peak Rated Capacity for Financial Year 2020-21, 2021-22, and 2022-23 respectively and corresponding replies of the Allottee were considered in the meeting.

	Allottee further informed that the company has undergone CIRP through NCLT and they were forbidden by the bank for any further investment and the owner of the company wanted to have a comprehensive detailed plan for the whole mine before going forward.	
	O/o Nominated Authority informed that the mine was allocated in the year 2015 and the decision for further drilling and GR preparation should have been taken by Allottee in the beginning itself. However, they delayed in taking such decision. It is due to financial distress condition of the company and the promotor's decision for delaying the mining that the production has not yet started.	

#### **Observation & Recommendation:**

The Committee observed that the three months' time was given to the Allottee to show tangible progress as assured by them in its 19<sup>th</sup> meeting. However, the Committee observed that there is not much change in the situation in the last couple of months and that as of now there is no scope to give further time. The current situation as indicated by the Allottee shows that quite a few more activities such as preparation of revised Mining Plan are to be done and thus the mining is likely to be further delayed. The Committee is of opinion that the Allottee is mainly responsible for delay in starting mining and for shortfall in coal production in FY 2020-21, FY 2021-22 and FY 2022-23. The Committee, therefore, recommended for appropriation of PBG as per the provision of the Coal Mines Development and Production Agreement (CMDPA).

#### 17. Marki Mangli-II Coal Mine: - M/s Yazdani International Private Limited

Show Cause Notice dated 21.09.2022 for delay in submission of Mining Lease Application and for delay in approval of Mining Plan and the corresponding reply of the Allottee was considered in the meeting.

Due to failure in submission of compliances to all the points raised, the proposal for approval of revised Mining Plan was rejected. Again, a fresh Mining Plan was submitted by Allottee in June 2022, and this was finally approved in October 2022. Representative of coal ministry informed that the Allottee have failed to get approval of Mining Plan even within the revised timeline.	

#### **Observation & Recommendation:**

Show Cause Notice was issued for delay in submission of Mining Lease Application and for delay in approval of Mining Plan. The due date for completion of this milestone is 03.12.2021 while the actual date is 13.10.2022. During the discussions, it was observed that the Mining Plan was submitted in October 2021. The representative of CCO mentioned that the submitted mining plan was not complete in all aspect and accordingly observations were raised. Even the compliances submitted by the Allottee were not complete and therefore the Mining Plan was not approved at first instance. Again, a fresh Mining Plan was submitted in June 2022 for approval. The Committee is of the opinion that the responsibility of submission of Mining Plan which is complete in all aspect lies with the Allottee and therefore the reasons for the delay in approval of Mining Plan is attributable to the Allottee. The Committee recommended for appropriation of PBG as per the Coal Mine Development and Production Agreement (CMDPA) for delay in approval of Mining Plan.
