Dear Sir,

With regard to significant activities of Ministry of Coal during June, 2025, information in respect of point no. (i) to (iii) specified in your DO letter No. 1/50/3/2024-Cab. dated 24.10.2024 is NIL and details on Departmental indicators as per the format circulated vide your DO letter of even number dated 03.12.2024 is Annexed.

2. With respect to point no. (iv) *ibid.*, regarding significant developments, I would like to inform that the overall coal production in June 2025 was 78.83 MT and the coal stock at the Thermal Power end as on 30.06.2025 is 58.29 MT which is sufficient for 27 days (@ present 2.15 MT/day consumption). Further, this is 102% of the normative coal stock for Q2, prescribed by the Central Electricity Authority.

3. I would like to highlight the following major developments during the month of June, 2025:

- a. Revised Jharia Master Plan (JMP) for addressing issues related to fire, land subsidence, and the rehabilitation of affected families in the Jharia Coalfields was approved by the Cabinet on 25.06.2025. The Revised JMP lays a much stronger emphasis on sustainable livelihood generation for families being resettled under the plan. Targeted skill development programmes would be undertaken and income-generating opportunities would be created to ensure economic self-reliance of the rehabilitated families.

Furthermore, a Livelihood Grant of Rs. One Lakh and access to credit support upto Rs. Three Lakhs through an institutional credit pipeline will be extended to both Legal Title Holder (LTH) and Non-Legal Title Holder (Non-LTH) families.

In addition, comprehensive infrastructure and essential amenities—such as roads, electricity, water supply, sewerage, schools, hospitals, skill development centres, community halls, and other common facilities—are to be developed at the resettlement sites. These provisions will be

implemented in a time bound manner in close co-ordination with the Govt. of Jharkhand as per the recommendations of the Committee for Implementation of the Revised Jharia Master Plan, ensuring a holistic and humane rehabilitation approach.

- b. C CARES version 2.0, a web portal of Coal Mines Provident Fund Organization (CMPFO) developed and designed by the Centre for Development of Advanced Computing (CDAC) was launched on 03.06.2025. The current version of the portal has been developed with an aim to further advance welfare of coalmine workers by streamlining the PF/Pension disbursement and bringing Coal workers, the Coal management and Coal Mines Provident Fund Organization onto a unified digital platform.
- c. The Nominated Authority, Ministry of Coal in the month of June 2025 opened the bids for the 12th round of commercial coal blocks auction (including 6 underground coal blocks). The round received a good response for the bidders and 13 bids have been received for 28 coal blocks (including 2 underground coal blocks).
- d. NLC India Renewables Limited (NIRL), the renewable arm of NLC India Limited, has successfully won a 500 MWh Battery Energy Storage System (BESS) project from Tamil Nadu Green Energy Corporation Limited (TNGECL) with VGF of 135 crores from GOI.

This marks NLCIL's foray into utility-scale energy storage and is the one of first such project of its kind by a PSU. It represents a transformative step in our contribution to India's clean energy mission and sets a benchmark in the Coal Ministry's vision for diversified and sustainable growth.

The project is a strategic leap forward, aligning with the Hon'ble Prime Minister's commitment to achieving net-zero by 2070 and establishing India as a global green power hub.


- e. Central Mine Planning and Design Institute, a subsidiary of Coal India Limited under the Ministry of Coal conducted a Hackathon on Carbon Capture Technology, from 12th May, 2025 to 10th June, 2025 focussing on three problem statements viz. Direct Air Capture (DAC) of GHG, Geological storage of captured CO₂ in the coal bearing regions of India & development of carbon capture-based bio-fuel utilizing algae cultured in the mine pit lakes.

- f. Northern Coalfields Limited (NCL), a subsidiary of Coal India Limited under the Ministry of Coal secured the 2nd position in the prestigious 19th National Awards for Excellence in Cost Management-2024 under the Manufacturing-Public-Mega category, awarded by Institute of Cost Accountants of India (ICMAI).
- g. Under the FMC initiative at Western Coalfields Limited (WCL), the first CHP-Silo circuit (FMC-I) at MKD-III in Umrer Area has been successfully operationalized on 30.06.2025. Coal offtake through Silo circuit has commenced, marking a significant milestone in enhancing coal evacuation efficiency and supporting environmentally sustainable operations.


