INTERNATIONAL COOPERATION

A. Strategic Collaborations of CIL through MoUs

MoU signed between CIL and Curtin University (Australia):

Signed on 28.01.2025 at Curtin University, Perth, this partnership focuses on research and development collaboration in critical minerals, decarbonization, and resource technologies. It involves knowledge sharing through Curtin's West Australian School of Mines and positions CIL to benefit from global expertise in mineral processing and sustainability.

B. International Engagements

CIL has actively participated in the following global conferences and events to strengthen its international presence and knowledge base in critical minerals:

- a. International Mining and Resources Conference (IMARC), Australia: IMARC events has provided exposure to global mining practices, investment opportunities, and technology trends.
- b. PERUMIN: PERUMIN is one of the world's most significant mining conventions, held biennially in Arequipa, Peru, by the Peruvian Institute of Mining Engineers (IIMP). During this summit, CIL has interacted and discussed collaboration opportunities with potential asset owners of copper, lead, critical minerals and anthracite coal.
- c. Other Study related and Invitation based Events: Participation in specialized forums and workshops enhanced CIL's understanding of global critical mineral strategies and positioned it as a proactive

player in the international arena.

To enhance participation of country in Global Bodies & Institutions like World Mining Congress, Global Methane Initiative etc.

SCCL Initiatives in Critical Minerals

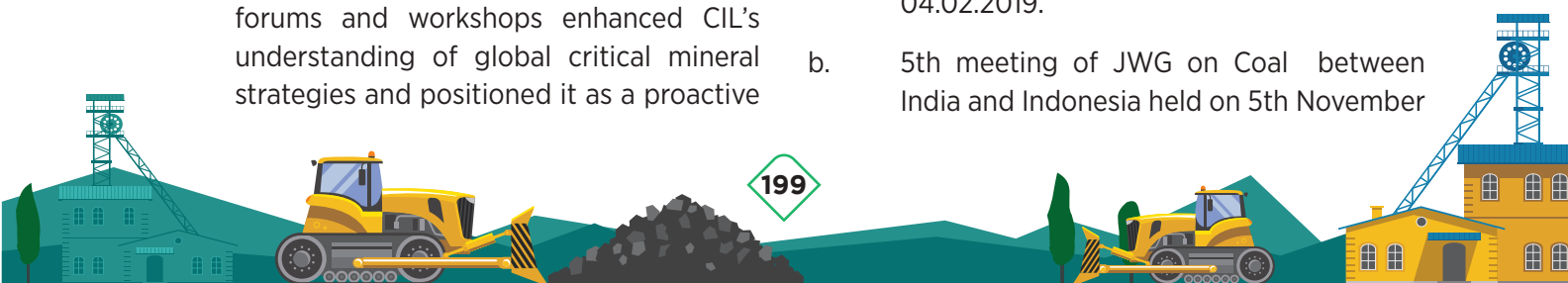
Singareni Collieries Company Limited (SCCL) is a state-level Public Sector Enterprise jointly owned by the Government of Telangana (51%) and the Government of India (49%). The company contributes around 7.5% of India's total coal production.

SCCL has had discussions with the Representatives of RosAtom, Russia for exploring the opportunity of acquisition of Copper and Lithium Mines in Russia, Kazakhstan, Mali etc. and M/s Austrade, Australia for overseas collaborations. Further, SCCL is participating in discussions of Joint Working Committee (JWC) - KABIL for exploring the opportunities for overseas assets acquisition. Discussions with other countries such as Ghana, Brazil etc. on critical minerals are in progress.

D. Memorandum of Understanding (MoU)/ Joint Working Groups (JWG) of Ministry of Coal-

This Ministry has signed the following MOUs/ JWGs with other countries-

- a. MoU between the Ministry of Energy of the Republic of Poland and the Ministry of Coal of the Republic of India on cooperation in the area of coal mining signed on 04.02.2019.
- b. 5th meeting of JWG on Coal between India and Indonesia held on 5th November



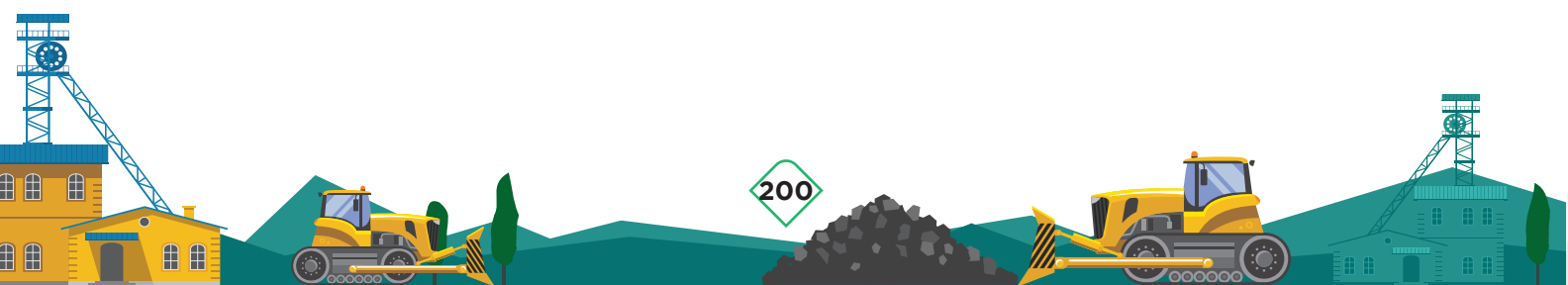
